



2	Eligible Bidders	<p>1. A Bidder may be a company, partnership firm, Proprietary firm, Government owned entity etc.</p> <p>2. Bidder should: - (A Self Certified letter duly signed by the Auth. 

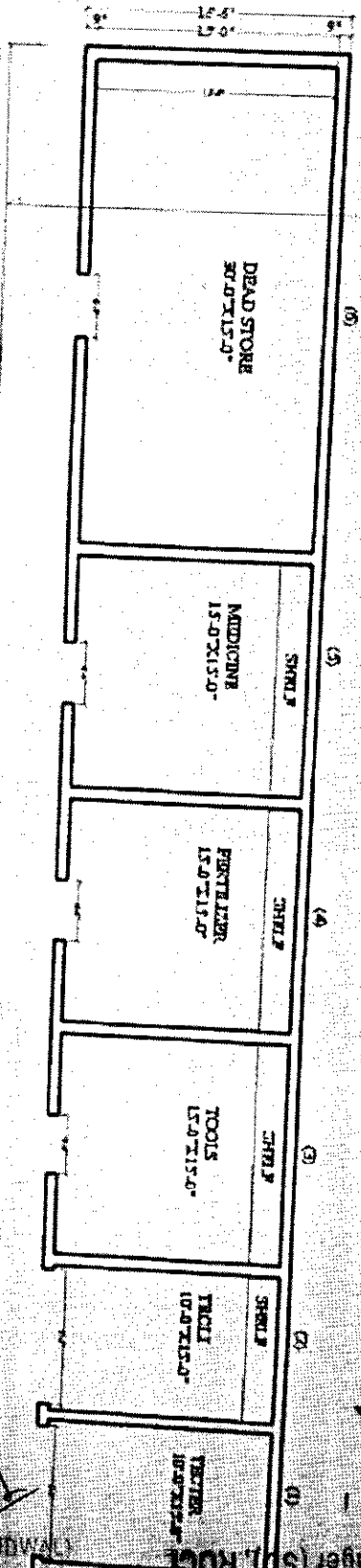
